

Waiver of liability for Bass Rock Landing

This Waiver of Liability (the "Release") executed on this _____ day of _____ by (the "Participants") in favour of the Scottish Seabird Centre (a non-profit charity) and/ or Seafari and/ or approved agents.

I hereby freely and voluntarily, without duress, execute the Release under the following terms:

1. Waiver and Release. I, the Participant, release and forever discharge and hold harmless the Scottish Seabird Centre and/ or Seafari and/ or approved agents from any claim or liability the I, the Participant, may have against the Scottish Seabird Centre and/ or Seafari and/ or approved agents with respect to bodily injury, personal injury, illness, death or property damage that may result from my participation on a Bass Rock Landing Trip (except in the case of negligence by the Scottish Seabird Centre and/ or Seafari and/ or approved agents)
2. I understand that Bass Rock is managed for nature, and that to minimise any disturbance to breeding seabirds I will stay with a Scottish Seabird Centre guide at all times and follow any requests they may make.
3. I also understand that the Scottish Seabird Centre and/ or Seafari and/ or approved agents do not assume any responsibility or obligation to provide financial or other assistance, including, but not limited to medical health, or disability insurance, in the event of injury, illness death or property damage.
4. Insurance. The Scottish Seabird Centre and/ or Seafari and/ or approved agents do not carry or maintain, and expressly disclaim responsibility for providing any health, medical or disability insurance coverage for the Participant. EACH PARTICIPANT IS EXPECTED AND ENCOURAGED TO CARRY PERSONAL LIABILITY OR HEALTH INSURANCE PRIOR TO REGISTERING FOR A BASS ROCK LANDING TRIP.
5. Medical Treatment. Except as otherwise agreed to by the Scottish Seabird Centre and/ or Seafari and/ or approved agents in writing, I hereby release and forever discharge the Scottish Seabird Centre and/ or Seafari and/ or approved agents from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time on the Bass Rock Landing Trip.
6. Assumption of Risk. I understand that my time on the Bass Rock Boat Trip may include activities that may be hazardous to me, including, but not limited to, boarding and disembarking from the boat, loading and unloading of my equipment and being in a remote location. I hereby expressly and specifically assume risk of injury or harm in these activities and release the Scottish Seabird Centre and/ or Seafari and/ or approved agents from all liability for injury, illness, death or property damage resulting from the activities of my time on the Bass Rock Landing Trip.
